**WAIVER AND INDEMNITY :**

I, THE UNDERSIGNED, HERINAFTER REFERRED TO AS THE 'PARTICIPANT' DULY AUTHORISED THERETO HEREBY DECLARE TOWARDS AND IN FAVOUR OF SABEEMER 'THE OWNER' WHO OWNS AND/OR MANAGES AND/OR 'THE ORGANISERS' A RACING TRACK KNOWN AS 'SALDANHA AIRFIELD' (HERINAFTER REFERRED TO AS 'AMSC') THE FOLLOWING :

1. I PARTICIPATE AT SALDANHA AIRFIELD AT MY OWN RISK
2. I HEREBY WAIVE AND ABANDON ANY CLAIMS, OR WHATEVER NATURE, ARISING FROM THE USE OF ME AT SALDANHA AIRFIELD WHETHER RESULTING FROM DEATH, BODILY INJURY OR OTHERWISE WHICH I MAY HAVE AGAINST SALDANHA RACEWAY AND/OR THE ORGANISERS FROM WHATEVER CAUSE.
3. I HEREBY INDEMNIFY SABEEMER AND/OR THE ORGANISERS AGAINST ANY AND ALL CLAIMS OF WHATSOEVER NATURE, WHICH MAY BE INSTITUTED AGAINST SABEEMER AND/OR THE ORGANISERS ARISING FROM THE USE BY ANY PARTICIPANT AND/OR PERSON OF SABEEMER, WHILE I PARTICIPATE AT SALDANHA AIRFIELD.
4. THE WAIVER AND INDEMNITY SHALL APPLY TO MY SUCCESSORS, ASSIGNS, DEPENDANTS, AND HEIRS.
5. THE ONLY RESPONSIBILITY OF SABEEMER AND THE ORGANISERS IS PROVIDE A PLACE TO RACE WHICH INCLUDES THE NECESSARY EMERGENCY SERVICES I.E FIRE AND MEDICS
6. PRIME RESPONSIBILITY FOR THE SAFE CONDITION AND OPERATION OF A VEHICLE IN COMPETITION RESTS WITH THE VEHICLE OWNER AND DRIVER.
7. DRIVERS ARE REQUIRED TO HAVE A VALID DRIVERS LICENSE AND MUST BE CAPABLE OF THE SAFE OPERATION OF THE VEHICLE.
8. THE MAIN PURPOSE OF THE ARMCO BARRIERS IS TO PROTECT THE PAYING PUBLIC.
9. THIS ENTRY FORM REMAINS THE PROPERTY OF SABEEMER AND MAY NOT BE REMOVED UNDER ANY CIRCUMSTANCES.
10. IT IS THE RESPONSIBILITY OF THE PARTICIPANT TO ENSURE THAT ALL INFORMATION CONTAINED ON THIS ENTRY FORM IS CORRECT.
11. I HEREBY DECLARE MYSELF TO BE FULLY ACQUAINTED WITH THE NATURE AND EXTENT OF THE RISKS INVOLVED IN PARTICIPATING AT SALDANHA AIRFIELD, WHICH RISKS INTERALIA ARISE FROM HIGH SPEEDS AND/OR UNCONTROLLABILITY OF VEHICLES USING SALDANHA AIRFIELD , AND FURTHER SPECIFICALLY INDEMNIFY SALDANHA AIRFIELD AND/OR THE ORGANISERS AGAINST ANY AND ALL CLAIMS ARISING RELATED TO SUCH RISKS.

**PROHIBITED SUBSTANCE**

I AGREE TO ALLOW A MEDICAL PRACTITIONER TO EXAMINE ME PRIOR TO OR DURING OR FOLLOWING A MOTOR SPORTING EVENT, MEETING OR COMPETITION. I FURTHER AGREE TO ALLOW A SAMPLE OF MY BLOOD AND/OR URINE TO BE TAKEN FOR LABORATORY ANALYSIS BY THE MEDICAL PRACTITIONER CONCERNED TO DETERMINE THE PRESENCE OF ALCOHOL OR PROHIBITED DRUGS AS LISTED BY THE FEDERATION INTERNATIONALE DUE SPORT AUTOMOBILE (FISA) AND/OR FEDERATION INTERNATIONALE MOTORCYCLISTE (FIM) AND IN ACCORDANCE WITH THE PROCEDURE FOR TESTING AS PRESCRIBED BY THEM. SHOULD THE ANALYSIS SAMPLE TAKEN REVEAL THE PRESENCE OF ALCOHOL OR DRUGS OR SHOULD I REFUSE TO ALLOW SAMPLES OF BLOOD AND/OR URINE TO BE TAKEN, I AGREE TO MY SUSPENSION FOR 12 MONTHS FROM PARTICIPATION OF ALL FORMS OF MOTORSPORT WITHOUT ME BEING ALLOWED RECOURSE THROUGH APPEAL AGAINST THE 12 MONTH SUSPENSION IMPOSED FOR USING ALCOHOL OR DRUGS OR FOR REFUSING TO ALLOW SAMPLES OF URINE OR BLOOD TO BE TAKEN AS PER THIS AGREEMENT.
